Privacy Policy

Your privacy on the Internet is important to us. This privacy policy discloses what information we gather, how we use it, and how to correct or change it.

1. General:

- 1.1 Nfinite Solutions Ltd T/A Infinity Property Management complies with the New Zealand Privacy Act 1993 (the **Act**) when dealing with your personal information.

2. We collect the following information about you:

- 2.1 Name;
- 2.2 Contact information;
- 2.3 Location;
- 2.4 Computer or network;
- 2.5 The way you interact with us, including the way you interact with us on any of our social media accounts;

3. Cookies:

- 3.1 Cookies are small pieces of information that are stored in a browser-related file on your computer's hard drive when you use our Web site. Cookies are widely used on most major Web sites. Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. A cookie in no way gives us access to your computer or any information about you other than the data you choose to share with us.
- 3.2 We may use information contained in cookies to make assumptions about the user of the computer and to provide users of that computer with focused advertising that we believe may be of interest, based on that information.
- 3.3 You can choose to accept or decline cookies. Most web browsers automatically accept cookies but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of our website.

4. We collect your personal information in order to:

- 4.1 Verify your identity;
- 4.2 Respond to communications from you, including any complaints;
- 4.3 Provide services and products to you;
- 4.4 Undertake credit checks of you;

- 4.5 Protect and/or enforce our legal rights and interests, including defending any claim;
- 4.6 Do any other thing authorised by you or the Act.

5. Besides our staff, we share this information with:

- 5.1 Another company within our group;
- 5.2 Any business that supports our services and products, including any person that hosts or maintains any underlying IT system or data centre that we use to provide the website or other services and products;
- 5.3 A credit reference agency for the purpose of credit checking you;
- 5.4 A person who can require us to supply your information (for example, a regulatory authority);
- 5.5 Any other person authorised by the Act or another law;
- 5.6 Any other person authorised by you.

6. If you have concerns about your privacy:
